1	Plaintiff-Intervenor the United States Department of Justice ("United States" or
2	"DOJ"), by and through counsel here undersigned, objects to the Special Master's June 4,
3	2014 Report and Recommendation (ECF No. 1612) ("June 4, 2014 R&R") on the Tucson
4	Unified School District No. 1's ("TUSD" or "District") Administrator and Certificated
5	Staff Outreach, Recruitment and Retention Plan ("ACSORR"). The references in that
6	document to DOJ's objections are incorrect, as DOJ did not object to the District's revised
7	ACSORR. Rather, the DOJ's objections referred to a prior version of the ACSORR,
8	provided by the District on July 30, 2013. With a limited exception, the District's May 22
9	
10	2014 ACSORR responded to DOJ's prior concerns. The only item DOJ requested that the
11	District has not provided is additional data adding comparative Metropolitan Statistical
12	Areas ("MSAs") to the Labor Market Study ("LMS"). However, DOJ agrees with the
13	Special Master's statement in the June 4, 2014 R&R that, because TUSD's recruitment
14	obligations do not hinge solely on the LMS, it is not necessary at this time to receive the
15	additional MSA data previously requested.
16	Therefore, the United States objects to the references in the June 4, 2014 R&R that
17	suggest that the DOJ agrees with any of the objections contained therein, and, further,
18	requests that such references be struck.
