#### AFFIDAVIT OF MARY DUNN BAKER, Ph.D.

I, Mary Dunn Baker, being duly sworn according to law, hereby depose and say:

I am above the age of 18 and am competent to prepare this Affidavit. I completed the Ph.D. in Economics in 1986 at Florida State University. I have been employed by ERS Group (ERS) since July 1986 where I presently serve as a Managing Director. ERS is a research and consulting firm whose professionals work with individuals, government agencies, colleges and universities, corporations and other organizations to analyze outcomes of employment decision-making processes and to compute the value of alleged economic losses. A true and correct copy of my curriculum vitae, including a list of cases in which I have given testimony, is attached hereto as Exhibit A. This Affidavit is based upon my personal knowledge, information and belief.

- 2. Counsel for the Tucson Unified School District (TUSD or the District) asked me to conduct statistical analyses to determine whether the racial and ethnic composition of TUSD's Teachers and Administrators employed in 2010 and 2012 is statistically consistent with relevant external labor market data. In response, I executed several statistical studies using professionally accepted methods of analysis. To prepare the studies, I relied on a variety of public data sources commonly used by social scientists to measure the availability of African-Americans and Hispanics for these occupations in the external labor market.
- 3. In his 06/03/2013 "Report and Recommendation Relating to TUSD's Action Plan for Recruitment and Retention," the Special Master states that the Fisher plaintiffs claim that the labor market studies that the District has offered are not usable because I am biased and that I slanted the evidence to support TUSD's position. Furthermore, he states that "[i]t seems

likely that the district selected the contractor for the study who it expected would deliver data supporting its position. Organizations often select consultants who they believe will provide evidence that supports positions they want to pursue or believe that they have attained."

- 4. At no time has TUSD's counsel or any District employee made any mention whatsoever as to the statistical conclusions that I should draw. I was simply asked to use my expertise to prepare the requested workforce analyses using professionally accepted methods and data sources.
- 5. When I commenced to conduct the analyses, I had no idea what patterns the data would reveal. As stated above, I conducted analyses using a variety of data sources to estimate African-American and Hispanic availability for the relevant TUSD positions. I reported the results of all of these analyses, regardless of the outcome.
- 6. As indicated above, neither the District's counsel nor any TUSD employee attempted to influence the manner in which I conducted the analyses, the data sources upon which I relied or the conclusions that I reached.<sup>1</sup> In fact, had they done so, I would have refused the engagement.
- 7. Perhaps the plaintiffs consider me to be "biased and slanted" because I have conducted statistical analyses of employment decision-making processes for hundreds of organizations (e.g., corporations, government agencies and educational institutions) over the last 28 years. However, something that they would not be able to discern from reviewing ERS' website or other materials describing my experience is that the results of many analyses that I have conducted over the years did not favor our client's position. In many of those instances, the unfavorable findings that I had to deliver gave me the opportunity to work with the

organization to determine the aspects of their decision-making processes that likely gave rise to the observed disparities. In some cases, because of the adverse findings and subsequent investigations, the organization altered its decision-making processes in ways that eliminated or minimized the negative impact that previous policies, practices or procedures had on relevant demographic groups.

- 8. The remarks in the Special Master's Report suggest that I did not provide any analyses that showed results that were statistically inconsistent with the race/ethnic-neutral model. The finder-of-fact should note that some of the early analyses that I prepared using data provided by select state Departments of Education, the U.S. Department of Education's NCES data and relevant 2000 Census data for select geographic areas produced statistically significant shortfalls in the number of African-American Teachers employed by TUSD.<sup>2</sup> In addition, the later analyses that I conducted using 2010 EEO-5 data for Arizona plus the six surrounding states<sup>3</sup> yield significant shortfalls in the number of TUSD African-American Teachers.<sup>4</sup>
- 9. In my 09/30/2013 report, I presented analyses of the demographic composition of the District's workforce using 2010 EEO-5 data for the state of Arizona only. The data for each of the Teacher and Administrator categories produce patterns that show that African-Americans and Hispanics were employed in both of these occupations in numbers consistent

with, or statistically significantly greater than, their representation among individuals who are likely qualified for and interested in the District's positions.

- 10. As I explained in the report, in my opinion, the EEO-5 Reports for Arizona public school systems are the most appropriate and reliable source for the measurement of African-American and Hispanic availability for the relevant TUSD jobs for two reasons. First, the fact that these individuals are employed in relevant Teacher and Administrator categories demonstrates their interest in and qualification for these occupations. Moreover, the fact that they were working in Arizona indicates that they are willing and able to accept employment in this geographic area.<sup>5</sup>
- 11. In my opinion, the most recent available EEO-5 Reports are superior to other readily available data sources that contain information about the demographic composition of Teachers and Administrators for at least three reasons. First, the entities required to complete the EEO-5 Report are similar in that they are all public school systems. Second, the data for each state are available as of the same point in time. Third, every covered public school district completes the EEO-5 form following the same set of instructions and using the same definitions of relevant terms. Accordingly, the use of EEO-5 reports overcomes some of the flaws in other data sets that the Special Master mentions in his 06/03/2014 Report.

Moreover, migration data compiled by the US Bureau of the Census [2006-2010 American Community Survey (ACS) County-to-County Migration Flows] indicate that African-Americans, say, in California and Texas, are less likely than Whites to move to Pima County, Arizona. If African-Americans are not as willing as other demographic groups to live in the geographic area where the District is located, then EEO-5 data that include states with relatively large African-American populations likely overstate the availability of African-Americans for Teacher and Administrator jobs in the Tucson area. [According to the ACS, over the period 2006-2012, on average, California's population was 6.13% African-American. According to the ACS migration data, over this same period, on average, only 3.18% of the Californians who moved to Pima County were African-Americans. The ACS data also show that over the period 2006-2010, on average, Texas' population was 11.56% African-American. Yet, on average, only 5.25% of the Texans who moved to Pima County were members of this demographic group.

12. I agree with the Special Master that a study that addressed all of the perceived flaws in the analyses that have been produced to date would be very expensive and require continual updating. Moreover, adequate data may not be readily available to account for factors such as "differences in salary and other benefits" and "the quality of life" in the economic and social context.
