On November 20, 2015, Tucson Unified School District No. 1 filed its Notice of Intent to File [ECF 1871] (“Notice”), as a result of a letter written by TUSD Governing Board member Michael Hicks to this Court (as referred to in the Fisher Plaintiffs’ Magnet Objection at ECF 1867-3). The Notice misspoke when it stated that the TUSD Governing Board had engaged the services of an independent investigator to investigate the allegations

1 the Hicks letter contains. Instead, TUSD has advised counsel its administration through its
2 General Counsel, not the Governing Board, actually engaged the investigator.

3 Nonetheless, when TUSD receives the report on that investigation, it will advise the
4 Court, the Special Master and the Plaintiffs of the outcome of that investigation and its
5 intended course of action in light of the report's findings. Accordingly, as amended, the
6 Notice is accurate.
