1	The Court directed the District to revise its update to the Family and Community
2	Engagement plan to add requirements for keeping individual school websites current
3	with newsletters and current schedules of events (site council, PTO, SCPC, Governing
4	Board meetings, etc.), in school family engagement guidelines, and provisions for
5	monitoring and support for schools, in accordance with the terms of its order dated April
6	22, 2019. The Court ordered the District to file a supplemental notice of compliance
7	within 30 days of its April 22 order. [ECF 2217, at 15.]

8 This supplemental notice reports on the efforts of the District to comply with the 9 Court's directives. The District has implemented an update to the FACE school family 10 engagement guidelines, which are attached hereto as Exhibit A, adding maintenance of 11 updated school websites as monthly school-site requirements. The District has described 12 the process and responsibility for development, monitoring and support for school 13 websites, as set out in Exhibit B.
