The Court directed the District to file an update to the FACE Action plan reflecting the Court's directives in its order dated September 6, 2018. [ECF 2123, at 132-137, 150-51.] The District filed the update on December 6, 2018. [ECF 2154.] In subsequent orders, the Court directed the District to make further revisions to the FACE Action Plan. [ECF 2213, 2217.] The District prepared a revised FACE Action Plan and provided it to the Special Master for review and comment. The Special Master provided thoughts and comments, along with additional requested provisions. The District further revised the FACE Action Plan to take into account the input from the Special Master. The resulting plan is attached hereto as Exhibit A.

The District respectfully submits that it has complied with the Court's orders, and has met the requirements of USP § VII, as shown by the record herein, including its annual reports and its prior assessment of compliance.¹ Accordingly, the District requests that the Court grant unitary status in this area of District operations (§ VII).²

The District recognizes that the Court has overruled these objections, but wishes to make clear that they are preserved for appeal.
