23 **SECOND SUPPLEMENTAL NOTICE AND REPORT OF COMPLIANCE:**
24 **PROFESSIONAL LEARNING PLAN FOR USE OF INSTRUCTIONAL**
25 **TECHNOLOGY IN THE CLASSROOM**
26 **(Orders 2123, 2217, and 2273)**

1 The Court directed the District to prepare and file a notice and report of
2 compliance with its directive to prepare a professional learning plan for teacher
3 proficiency in using technology. [ECF 2123 at 140, 151.] The District filed its plan in
4 December, 2018. [ECF 2152-1.] In subsequent orders (ECF 2217 and 2273), the Court
5 directed the District to make certain additions and clarifications to the plan. Accordingly,
6 the District has revised and restated its Professional Learning Plan for Use of
7 Instructional Technology in the Classroom, which the District believes complies with the
8 prior directives of the Court. A copy is attached hereto as Exhibit 1.

9 For the foregoing reasons, the District respectfully submits that it has complied
10 with the Court's orders, and requests that the Court grant partial unitary status in this area
11 of District operations (USP § IX.B).¹
