Pursuant to the Court's order dated November 18, 2019 (ECF 2364), the District has prepared a Supplement to its Analysis of Extra-Curricular Participation in District Schools, attached as Exhibit A. This Supplement identifies ten target schools that are both racially concentrated and have lower socioeconomic status, and provides a listing of all extracurricular activities offered by each school, along with baseline participation data for each activity. This Supplement further provides initial strategies used at these schools to increase both the offerings of extracurricular activities and participation within those activities.

As recommended by the Special Master and included in the November 18 Order, the Interscholastics Department is gathering and reporting baseline data, by school, for all extracurricular activities at all schools using the format prescribed by the Special Master. The Interscholastics Department will provide this data to all principals, by Christmas break, to enable them to make comparisons between their schools and similar schools and identify extracurricular activities and strategies to use to provide opportunities for interracial contact and to create positive settings of shared interest.
