1 Pursuant to Local Rule of Civil Procedure 7.2(i), the District respectfully requests
2 that the Court summarily grant its Motion for Leave to Exceed Page Limitation for
3 Supplemental Petition for Unitary Status (ECF 2405).

4 The underlying Motion for Leave to Exceed Page Limitation was filed on
5 December 31, 2019. Pursuant to Local Rule of Civil Procedure 7.2(c), the plaintiffs'
6 deadline to file any responsive memorandum in opposition to that motion was January 14,
7 2020. That date has come and passed; no response to the Motion for Leave to Exceed
8 Page Limitation has been filed.

9 Pursuant to Local Rule of Civil Procedure 7.2(i), if an opposing party "does not
10 serve and file the required answering memoranda, . . . such non-compliance may be
11 deemed a consent to the . . . granting of the motion and the Court may dispose of the
12 motion summarily." Because the plaintiffs have not filed any responsive memorandum
13 by the deadline, the District requests that the Court summarily grant its Motion for Leave
14 to Exceed Page Limitation for Supplemental Petition for Unitary Status, and direct the
15 Clerk to file the previously lodged Supplemental Petition for Unitary Status (currently
16 lodged at ECF 2406).
