1 Tucson Unified School District No. 1 respectfully requests leave to exceed the
2 page limitation imposed by Local Rule 7.2(e)(2) as to its Reply in Support of
3 Supplemental Petition for Unitary Status. The Supplemental Petition for Unitary Status
4 is lodged herewith.

5 Good cause exists to grant this request. The memorandum in opposition filed by
6 the Mendoza Plaintiffs exceeded the page limitation, and the Reply in support of the
7 Supplemental Petition addresses issues raised by the Mendoza Plaintiffs. A number of
8 those issues were not fully developed in the opposition and required more space to
9 respond than to raise. The nature and extent of the issues has required substantial work
10 and exposition to properly reply. With the broad scope and number of the reply is
11 unavoidably substantial.

12 Accordingly, the District requests leave to file the Supplemental Petition
13 containing no more than 65 pages, not including tables of contents and authorities. A
14 proposed form of order is attached hereto as Exhibit A, and the Reply in Support of
15 Supplemental Petition for Unitary Status is lodged herewith.
