**NOTICE OF DISCLOSURE AND COMPLIANCE WITH BENCHMARK FOR  
2020-21 USP BUDGET DEVELOPMENT PROCESS: DRAFT 2**

1 Pursuant to the SY2020-21 Revised Budget Development Process<sup>1</sup>, the benchmark  
2 deadline for submitting the Draft #2 USP Budget was May 5<sup>th</sup> (see Exhibit 1, Revised  
3 Budget Development Process). Tucson Unified School District hereby gives notice of  
4 disclosure and compliance that it submitted Draft #2, as described above, on Tuesday,  
5 May 5, 2020 (see Exhibit 2). On Thursday, May 7, 2020, the District received  
6 confirmation of receipt from Dr. Hawley's budget consultant, Dr. Vicki Balentine (see  
7 Exhibit 3). As explained in the Draft 2 cover letter, due to the COVID-19 pandemic,  
8 District resources have been prioritized towards addressing school closures, reallocating  
9 funding where most needed, creating online learning environments, and attempting to plan  
10 for the unknown future regarding summer school and the 2020-21 school year.  
11 Accordingly, it is not possible to provide the PD Assessment or accurate non-910G budget  
12 amounts at this time. However, the District anticipates that non-910G funding levels will  
13 remain relatively similar to the current school year.
