Pursuant to the SY2020-21 Revised Budget Development Process<sup>1</sup>, the benchmark deadline for submitting the Draft #2 USP Budget was May 5th (see Exhibit 1, Revised Budget Development Process). Tucson Unified School District hereby gives notice of disclosure and compliance that it submitted Draft #2, as described above, on Tuesday, May 5, 2020 (see Exhibit 2). On Thursday, May 7, 2020, the District received confirmation of receipt from Dr. Hawley's budget consultant, Dr. Vicki Balentine (see Exhibit 3). As explained in the Draft 2 cover letter, due to the COVID-19 pandemic, District resources have been prioritized towards addressing school closures, reallocating funding where most needed, creating online learning environments, and attempting to plan for the unknown future regarding summer school and the 2020-21 school year. Accordingly, it is not possible to provide the PD Assessment or accurate non-910G budget amounts at this time. However, the District anticipates that non-910G funding levels will remain relatively similar to the current school year.
