26 **(FIRST REQUEST)**

1 Tucson Unified School District respectfully moves for a three-day extension to
2 file: (a) its notice to the Court in response to the Court's order dated July 16, 2020
3 (ECF 2497) and (b) its reply in support of its Supplemental Notice and Report of
4 Compliance and Limited Request for Relief related to ALE programs (ECF 2500). The
5 deadline for both of these filings is currently August 17, 2020. However, due to school in
6 the District opening for online instruction last week, the District has encountered
7 difficulties and delays in completing those filings by the deadlines. The District is
8 therefore requesting that both deadlines be extended by three days, until Thursday
9 August 20, 2020, to give it time to complete the filings.

10 The District communicated with the plaintiffs and the Special Master regarding
11 this request. All have confirmed that they have no objection to the request.
