1 Subject to and without waiving its objections previously stated and referenced
2 herein, the District hereby provides notice of compliance with the Court's orders entered
3 on August 14, 2020 (ECF 2509), as amended by the Court's order entered on June 22,
4 2020 (ECF 2486), related to instructions for magnet principals in developing magnet
5 school plans.

6 In its Order of July 1, 2020, this Court directed the District to develop written
7 instructions for principals for preparing the magnet school plans (MSPs), including
8 instructions about priorities and spending targets, and file it as an addendum to the 3-
9 Year PIP: CMP (Id.). The District has developed a Magnet School Plan Development
10 Guide as an addendum to the CMP: PIP. The Guide has been provided to magnet
11 principals to use in developing MSPs and MSP budgets for SY2021-22.
