Training Information

Multiple trainings were provided for administration regarding the GSRR. Training was presented during an administrator's conference and 3 separate times during ILA meetings. Administrator's had the opportunity to ask clarifying questions and discuss disciplinary scenarios.

There was also an on-line training available to all certified and classified staff. This training was posted on True North. The presentation had links to the GSRR as well as some of TUSD policies. There was a test at the end of the training and the administrator would have to pass the quiz with 80% score to receive credit for the training.

Staff has many supports in place if there is any need for clarification regarding the GSRR. They have their colleagues, directors, and assistant superintendents if they needed guidance or clarification on a particular violation.
