AASPA Membership — Which Type is Right for Me?

There are six individual categories of membership:

- a. Individual Active. For school personnel whose responsibilities totally or primarily include school and district personnel administration and individuals whose assigned work includes personnel functions in other educational institutions. Full voting and office holding rights. Those eligible for Individual Active membership are practicing public and private school administrators.
- b. Associate. Associate Membership is open to any person who engages in, or is associated with an education institution, including university programs for the preparation of school personnel administrators, and is <u>not a school system leader</u>. Associate members shall be entitled to participate in all activities of the Association except voting and holding elective office. <u>Those eligible for associate membership are district professional staff, faculty members in post-secondary institutions, or employees in education-related agencies.</u>
- c. Retired. Any retiring member is eligible for retired membership provided he/she has had one year of Individual, Associate, or Institutional membership in the Association, and is <u>not a current school system leader</u>. Retired members shall be entitled to participate in all activities of the Association except voting and holding elective office.
- d. Honorary Membership may be accorded to persons who have distinguished themselves in school personnel work. Honorary members shall be entitled to participate in all activities of the Association except voting and holding elective office.
- e. Business Partners. Membership for supporting businesses, including teacher testing and placement as well as educational research, consultants, vendors, and exhibitors. Business partners shall be entitled to participate in all activities of the Association except voting and holding elective office.
- f. Student. Membership for individuals enrolled full or part time in an Educational Leadership graduate program in a degree granting institution, and is <u>not currently a school system leader</u>. Student members shall be entitled to participate in all activities of the Association except voting and holding elective office.

There are two sub-categories of membership:

- g. Institutional Individual Active Primary Membership. For school personnel whose responsibilities totally or primarily include school and district personnel administration and individuals whose assigned work includes personnel functions in other educational institutions. Full voting and office holding rights. Those eligible for Institutional Individual Active membership are practicing public and private school administrators.
- h. Institutional Associate Membership. For <u>additional school personnel</u> who are engaged in, or associated with an education institution whose responsibilities totally or primarily include school and district personnel administration and individuals whose assigned work includes personnel functions. Institutional Associate members shall be entitled to participate in all activities of the Association except voting and holding effective office.
