

Utterback on the list again with nearly double the number of DOC incidents and a high number of Disruption/Defiance. Gridley has come onto the list with a high number of disruption and defiance. Secrist has reduced its level on the KPI from 2.4 to 1.8 and DOC and Fighting are no longer in the top 4 actions, replaced by tardies and inappropriate language.

Overall, level 2 offenses are those seen the most especially at Secrist and Gridley. Utterback and Pistor have level 3 with fighting and DOC as primary violations.


