1 Defendant Tucson Unified School District hereby files its Annual Report for the
2 2016-17 school year as required by the Unitary Status Plan (ECF 1713). The Annual
3 Report has ten major constituent sections, each corresponding to a major section of the
4 Unitary Status Plan. This Annual Report is not due until October 1, 2017, but the
5 District has worked hard to finish it early in the hope that it will speed the analysis of the
6 District's compliance with the USP as contemplated by the Court in its recent orders.

7 The Annual Report itself appears as Attachment Number 1 to this document. For
8 ease of reference, the appendices, including reports required by the Unitary Status Plan,
9 are grouped by section of the Annual Report, and appear in the docket as separate filing
10 documents. An index to the appendices appears as Attachment Number 2 to this
11 document.

12 The Court also ordered the District to present "an analysis of the extent to which
13 the District has met the provisions of the USP" (ECF 2050) in connection with its
14 Annual Report. This analysis will be presented as an annex to this Annual Report to be
15 filed on or before the October 1 annual due date for the District's annual report.
