Scope of Work: This grant is being awarded to the Grantee to provide organization funding to distribute shelf stable food and fresh food to meet the increased demand resulting from the impact of the COVID-19 pandemic.

Funds may not be used to pay any government agency including SRP.

Funds may only be used to pay for expenses incurred from the date of this signed agreement.

As such, the grantee may be subject to a review and/or audit by a government agency in regards to this award up to six years.

- Submit monthly distribution data to AzFBN, specifically number of pounds of food received and number of households served.
- Retain all pertinent financial records in regards to the disbursement of award monies including receipts, purchase orders, payroll records, and quotes (as applicable).

• Submit any press releases or planned outreach to media outlets to AzFBN for review prior to submission.
