21-22: A Grounds Foreman was added to assist with the increased workload.

22-23: The district added 3 Preventative Maintenance Techs to the Fire Safety crew and removed 1 locksmith and 1 electrician to cover the cost. GB approved increase of 5 FTE to Grounds Crew.

23-24: Added 1 Pesticide Qualified Party; Added 1 Plumber/Welder; Removed 1 Electrician and added 1 Fire Safety Tech.
